## 1. INTRODUCTION

- 1.1. The Mayibuye Transport Corporation operates as a parastatal bus passenger transport service provider belonging to the Eastern Cape Provincial Government.
- 1.2. The Vision of the MTC is to become the Public Transporter of Choice.
- 1.3. It is the mission of the MTC to provide a safe, reliable, affordable public transport service that is responsive to its environment.
- 1.5. The prices tendered must be valid for 90 days.
- 1.5. There will no briefing sessions
- 1.6. All submissions must be made electronically to the email address provided; [tendersubmissions@mtcec.co.za](mailto:tendersubmissions@mtcec.co.za)
- 1.7. All submissions must be indexed appropriately

## 2. BACKGROUND

3. MTC has 84 **Buses**, four depots and 14 **Ancillary Vehicles** to collect revenue and generate income. The buses travel on tarred and gravel roads, mostly gravel roads, which cause damage to the windscreens and side windows. The windows and windscreens need to be replaced in the shortest possible time as broken glasses can make a bus not roadworthy. It is for this reason the replacement of glass needs to be done quickly. Once the bus is not roadworthy it will be parked and not generate income for MTC.
4. The four depots are situated in the following areas, Alice, Zwelitsha, Reeston and Queenstown

## 3. REQUIRED PRODUCTS AND SERVICES

3.1 The tenderer shall cater for the following:

### 3.2 Glasses that MTC requires are as follows:

- 3.1.1 Windscreens – Front, Both Left and Right, sealer bonded and rubber mounted.
- 3.1.2 Quarter Glasses – Both Left and Right, sealer bonded.

- 3.2.2 Side Passenger Windows – Both Left and Right, with slider, sealer bonded, and rubber fitted.
- 3.2.3 Side Passenger Windows – Plain / Flat Glass – sealer bonded, and rubber mounted.
- 3.2.4 Right hand side driver’s door sliding glasses, rubber mounted.
- 3.2.5 Left hand side passenger door glasses. Sealer bonded.and rubber mounted.

3.3 The Corporation will not be held liable for any damages during the supply, delivery and installation of glasses. In a case where a glass was damaged beyond repair, the service provider is responsible to supply a replacement windscreen or glass within one (1) working day.

**4.1 There are different body types which listed below:**

- 4.1.1 Busmark Body
- 4.1.2 Marcopolo Body
- 4.1.3 Busaf Body
- 4.1.4 Predator/Buscor/Busafrika Body
- 4.1.5 MAN Body

**4.2 Site For Repairs:**

The repairs will be done on site at MTC premises located on all four depots namely Reeston, Alice, Zwelitsha and Queenstown.

**4.3 Disposal of Damaged Stock and residual material.**

The service provider will be responsible for disposal of damaged /scrap windscreens and residual material in environmentally friendly and compliant manner.

**4.4 Service Provider Requirements.**



All service providers to comply with MTC supply chain policy requirements.

All Glasses supplied and fitted should be SABS compliant.

All service providers to utilise own resources, materials and equipment to deliver service across all MTC sites.

## 5.COMPLIANCE

Bidders are required to include in their bid document the following:

5.1 A signed pricing schedule. The pricing schedule must include all costs and costs must be displayed per device per location. Each cost must be displayed as a separate line item. All costs must be VAT-inclusive.

5.2 A certified copy of the service provider's accreditation with its hardware vender.

5.3 A certified copy of the business registration documents issued by either the Companies and Intellectual Property Commission (CIPC) or the Department of Trade and Industry.

5.4 Bidders are to submit confirmation of their registration in the centralised supplier data base

5.5 An original valid BBBEE certificate.

5.6 A Certified copy of the identity document for each of the company directors of owners as they appear in the business registration documents as per 4.1 above.

5.7 Original and signed MTC SBD 1 Form "Invitation to Bid". Each page must be initialled.

5.8 Original and signed MTC SBD 3.1 Form "Firm Pricing Schedule". Each page must be initialled.

5.9 Original and signed MTC SBD 4 Form "Declaration of Interest". Each page must be initialled.

5.10 Original and signed MTC SBD 6.1 Form "Preferential Points Claim Form". Each page must be initialled.

5.11 Original and signed MTC SBD 8 Form "Past Supply Chain Practices". Each page must be initialled.

5.12 Original and signed MTC SBD 9 Form "Certificate of Independent Bid Determination". Each page must be initialled.

5.13 Details of the bidder's local support team operating out of an office based in the Eastern Cape. Proof of bidder's office may be in the form of lease agreements or utility bills in its name.

5.14 Failure to submit any of the above documents may render the proposal non-responsive and it will be disqualified from the bid process. Where possible the corporation reserves the right to request further particulars



## 6. FUNCTIONALITY

The evaluation of technical proposals will be on the basis of their responsiveness to the Terms of Reference, applying the evaluation criteria and point system indicated below. Each responsive proposal will be given a technical score. A proposal considered to be unsuitable shall be rejected at this stage if it does not respond to important aspects of the Terms of Reference. The MTC shall notify bidders of the rejection of their technical proposal after completing the selection process.

Tenders will be awarded on the absolute discretion of the Board with the recommendation of the Finance and Investment Committee, in accordance with internal policies and statutory regulations. The decision will be final and binding, no correspondence will be entered into.

- 6.1 Bidders are required to include in their bid document, a **detailed project process plan** for the supply, fitting, installation of all glasses by the service provider with specific timelines.
- 6.2 Bidders will assign a dedicated account manager to manage the contracts / account.
- 6.3 Bidders are required to prove their experience in relation to the scope of the tender by submitting the contact details of at least 2 corporate clients that would demonstrate their competence to meet the full range of requirements of the Mayibuye Transport Corporation. **Letters of reference must be included** stipulating the service which was rendered by the bidder and the contract time frame and value.

Threshold to qualify for the second stage of evaluation is 60 points of the functionality scores. Therefore no bid will be regarded as an acceptable bid if the bidder fails to achieve the minimum qualifying score for functionality as indicated. Successful bidders at this stage will be further evaluated in terms of the PPPFA using the 80/20 scoring.

## TENDER AWARDING PROCEDURE

- 6.4 In addition to the requirements as stated, all bids will be evaluated based on price and proposal and the proposal that will best suit the corporate operational requirements of the Mayibuye Transport Corporation.
- 6.5 The bid will be evaluated based on the Preferential Procurement Policy Framework Act (Act No. 5, 2000), and the regulations pertaining thereto (2017) as well as Mayibuye Transport Corporation's Procurement policy.



6.6 Received Qualifying Proposals will be evaluated based on the following criteria, namely:

- 6.6.1 Stage 1 – Mandatory Compliance
- 6.6.2 Stage 2 - Functionality
- 6.6.3 Stage3 – Price and Specific Goals

6.7 All documents relating to mandatory compliance must be submitted by the tenderer in order to proceed to stage 2.

6.8 A minimum score of **60 points** is required for the bid to proceed to stage

### 6.9 Mandatory Compliance – Stage 1

Bids will be evaluated for the submission of the documents as detailed in point 4, failure to submit the documents, as detailed therein, will render the proposal invalid and it will automatically be disqualified from the bid process.

### 6.10 Functionality – Stage 2

The technical proposal evaluation criteria and point system is as noted above (point 6); The weighting that will be applied is as follows;

Score	Prompt for judgement
0	Failed to address the issue
1	A detrimental response / solution – limited or poor evidence of skill / experience sought or high risk that relevant skills will not be available
2	Less than acceptable – response / solution lacks convincing evidence of skill / experience sought or medium risk that relevant skills will not be available.
3	Acceptable response / solution to the aspect of the requirements and evidence given of skill / experience sought
4	Above acceptable – response / solution demonstrating real understanding of requirements and evidence of ability to meet it.
5	Excellent – response / solution gives real confidence that the tenderer will add real value.

The scores of each of the evaluators will be averaged, weighted, and then totalled to obtain the final score.

### 6.11 80/20 Preference Points– Stage 3

The stage is the evaluation of the bids in line with the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).



Please note this is a Broker Services Tender only, submissions should include brokerage fees only for the purposes of price evaluation.

The points will therefore be allocated at this stage as follows;

In terms of the Procurement Policy of the Mayibuye Transport Corporation, the 20 points will be claimed by bidders in terms of the below specific goals of the Corporation;

**Note: bidders will claim points out of 20 according to the above percentages with those specific goals that the bidder meets. No bidder will be disqualified for not obtaining any points for specific goals but that no points will be for those specific goals not met.**

## **CONDITIONS**

- 6.12 The service providers are invited to submit a detailed proposal, that includes the tender document, deliverables and quotation for services to be rendered in South African Rand including VAT. A company profile should be attached as an appendix;
- 6.13 The tender must be submitted via a link which will be provided;
- 6.14 The Corporation reserves the right to reject any and/or all bids, to waive any and/or all formalities and to accept the one deemed most advantageous to Mayibuye Transport Corporation and the Province of the Eastern Cape.
- 6.15 The company name and the return address must also be endorsed on the back of the envelope;
- 6.16 If a courier service company is being used for delivery of the tender document, the tender description must be endorsed on the delivery note/courier packaging to ensure that documents are delivered into the correct tender box. It is the responsibility of the bidder to ensure that the bid is deposited in the correct box by closure of the tender.
- 6.17 No tender received late or by telegram, telex, email, facsimile or similar medium will be considered;
- 6.18 Where a tender document is not in the tender box at the time of the tender closing, such a tender document will be regarded as a late tender. Late tenders will not be considered;
- 6.19 Amended tenders may be sent in an envelope marked "Amendment to tender" and should be placed in the tender box before the closing time;
- 6.20 The tenderer is responsible for all the cost that they shall incur related to the preparation and submission of the tender document.
- 6.21 Kindly note that Mayibuye Transport Corporation is entitled to amend any tender conditions, validity period, specifications or extend the closing date of tenders before the prescribed closing date. All tenderers, to whom the tender documents have been issued, will be advised in writing of such amendments;
- 6.22 The Corporation reserves the right not to accept the lowest tender or any tender in part or in whole. It normally awards the contract to the tenderer who proves to be fully capable of handling the contract and whose tender is technically acceptable and/or financially advantageous to Mayibuye Transport Corporation – (in line with the MTC social aspirations);
- 6.23 The Corporation also reserves the right to award this tender as a whole or in part without furnishing reasons.
- 6.24 The Corporation also reserves the right to cancel or withdraw from this tender as a whole or in part without furnishing reasons.

- 6.25 The tenderer hereby offers to render all or any of the services described in the attached documents to the Corporation on the terms and conditions and in accordance with the specifications stipulated in this Tender document (and which shall be taken as part of, and incorporated into, this Proposal at the prices inserted therein);
- 6.26 This Proposal and its acceptance shall be subject to the terms and conditions contained in this tender document.
- 6.27 Tenders submitted by Companies must be signed by a person or persons duly authorised thereto by a resolution of a Board of Directors, a copy of which Resolution, duly certified be submitted with the Tender.
- 6.28 The tenderer hereby agrees that the offer herein shall remain binding upon him/her and receptive for acceptance by the Corporation during the validity period indicated and calculated from the closing hour and date of the Tender;
- 6.29 The tenderer furthermore confirms satisfaction regarding the correctness and validity of this Tender response and that all prices and rates quoted cover all the work / items specified in the Tender response documents and that prices and rates quoted cover all obligations under any resulting contract and that the tenderer accepts that any mistakes regarding prices and calculations will be at their own risk.
- 6.30 The tenderer hereby accepts full responsibility for the proper execution and fulfilment of all obligations and conditions devolving on him/her under this agreement as the Principal(s) liable for the due fulfilment of this contract.
- 6.31 Failure to comply with any of the terms and conditions as set out above will invalidate the tender.
- 6.32 Completion and signature of the "Details of the Tenderer" (Respondent) form (Form SBD1) are mandatory and confirm acceptance of these Terms and Conditions of Tender. Where the SBD1 document is not signed by the person authorised to sign, the bid will be disqualified.
- 5.34 The successful bidder will be required to enter and sign a Service Level Agreement which will apply for the duration of the contract term.
